Community-led action to cut carbon emissions, adapt to our changing climate and restore nature across Dorset

## Dorset's Local Nature Recovery Strategy now published and out for consultation.

It can be viewed <u>here</u>. Produced with key county stakeholders, the strategy aims to 'identify key pressures and opportunities for nature recovery and sets 12 nature recovery priorities supported by detailed activities'.

Dorset CAN has begun to discuss and formulate a response. Our nature-focused initiatives are focused on improving farmland by repairing, reinstating, and planting hedges through the Great Big Dorset Hedge Project, and improving the quality of our rivers and beaches. Both are based on volunteer work, through hedge surveys, hedge planting, and in due course even hedge-laying work parties, and citizen science monitoring of rivers, etc. Still, these aspects are barely addressed (at this stage) in the LNRS document.

# Dorset Council leader Nick Ireland addresses DCAN's AGM and new trustees appointed

Nick Ireland, leader of Dorset Council, addressed some 50 members on the council's plans for net zero, restoring nature and improving resilience in Dorset over the next few years at DCAN's online annual general meeting on 28 May.

He then answered a number of questions from members including on planning regulations, centrally imposed housing targets and why developers are not made to include solar panels, heat pumps and proper insulation in all new builds as standard. He blamed outdated regulations set by Whitehall.

At the annual meeting proper, Giles Watts was unanimously elected as the new chair of DCAN's trustees in place of Vicki Elcoate who is standing down after acting as chair since DCAN became a charity in 2022. Vicki was thanked by Giles for her massive contribution.

Three new trustees - John West, Nicola Harris and Max Griffith - were appointed. Jennifer Morisetti, who stood down as a trustee, was also thanked for her work as a trustee over the last four years.



## **Great Big Dorset Hedge Update**

There are usually twenty scheduled hedge surveys in the summer months, in different parts of the county and our winter volunteering should focus on hedge planting. Why not sign up with us and walk with knowledgeable and congenial companions while you record the state of the hedges. No previous knowledge necessary. Read about volunteering with the project here.

GBDH is already working with 100 farmers. Surveys are still needed & some planting has been done (for example: the project has been invited back to plant at Sherford Farm; 40km were surveyed at Rampisham Manor Farm, leading to some planting; similarly planting followed surveys at Manor Farm, Hammoon & Gorwell Farm near Abbotsbury). # DCAN Member News: Shaftesbury becomes Britain's first Nature Friendly Town

Shaftesbury Town Council declared itself to be Britain's first Nature Friendly Town in April after a recommendation by Sustainable Shaftesbury's advisory committee.

The council is now working with Dorset Wildlife Trust on a plan to introduce the idea nationally to all towns and parishes through the Wildlife Trusts national organisation, starting in Dorset.

The declaration follows the town council's earlier declaration of becoming an Orchard Town, with 'free-to-eat' fruit and nut trees being planted in public parks and open spaces instead of ornamental trees, as part of a ten-year tree and hedge planting policy and its adoption of 'Nature First' wildflower and allotments policies.

• Shaftesbury Town Council's former town clerk Brie Logan has joined Dorset Association of Parish & Town Councils (DAPTC) as training officer where it is believed she will be helping to promote carbon literacy training to town and parish councils among other innovations to how Dorset's councils work in the move towards greater decentralisation of councils in the south west.
